## **IST Portfolio**

IST3 INFRASTRUKTUR GLOBAL ("IST3 IG") is an actively managed investment group that invests in infrastructure assets directly and indirectly through direct assets, indirect single assets or diversified funds (primaries and secondaries) across OECD countries. IST3 IG is structured as an open-ended fund with no fixed duration, aligning its investment horizon with the economic life of its assets. The primary objective is to gain exposure to stable and predictable cash flows. Consequently, IST3 IG invests primarily into core private infrastructure brownfield assets with limited correlation to economic cycles across the following sectors: energy transmission/distribution/storage, energy generation, communication, transportation, social infrastructure and water and waste water.



#### Investment Approach and Sustainability

IST3 Infrastruktur Global ("IST3 IG") is an evergreen fund and pursues a long term buy-and-hold strategy for its infrastructure investments. In particular, infrastructure assets have the potential to make a positive ESG impact, not only due to their systemic nature, but also through the provision of crucial environmental and socio-economic services and functions. Thus, as an actively managed investment group with a long-term horizon, having a portfolio in line with relevant principles for responsible investments is of high importance. As an active promoter of responsible investing, IST3 IG believes that complying with certain ESG considerations in its investment and asset/portfolio management activities is essential to create value for its investors and to develop a sustainable long-term strategy for its assets.

IST3 IG's ESG policy strives at contributing to a tailored sub-group of UN SDGs, which serve as a toolkit to inform the activities of the investment and asset/portfolio management team. As such, fostering of energy efficiency, use of sustainable energy sources, promotion of education and science, ensuring health and safety, and the promotion of responsible business ethics are (among others) part of the UN SDG sub-group.
